The NIEA Regulatory Charging Policy applies to those businesses and activities regulated under Waste, Water and Pollution Control Regulations.

The NIEA Regulatory Charging Policy ensures that NIEA fully recovers the cost of regulating activities associated with its environmental legislation. It provides the facility to apply annual inflationary rises, as well as the opportunity to address over and under recovery that may arise in particular charging regimes. This is achieved largely through receipt of fees and charges set out in relevant charging schemes which are updated and published on an annual basis.

The current Regulatory Charging Policy covers the period April 2016 to the end of March 2021. It is proposed to extend the current Policy by a further two years until March 2023.

This two year timescale will allow sufficient time to procure and manage a suitably qualified consultancy to undertake a complete root and branch review of the regulatory charging policy. This is an opportunity to develop a sustainable long term regulatory charging policy that is also consistent with the other regulatory agencies within the UK, and addresses any requirements under EU-Transition and any anomalies within the current regulatory charging policy.
