

GENERAL

- · Use ballpoint pen to complete forms. Please write clearly.
- Use only MC2 forms and MC2S book of confirmation stickers that have been allocated to you.
- A movement licence, issued by DAERA is required before a restricted animal may be moved. The movement of restricted animals to or from your herd must also be notified to DAERA on MC2 forms.
- Should you lose either your book of MC2 notification forms or your book of MC2S confirmation stickers, you should notify your local DAERA Direct Office immediately.
- It is an offence to enter false information on the notification forms or to misuse the confirmation stickers.
- The notification forms and confirmation stickers will be rendered invalid should they be defaced in any way.
- Restricted animals should not be mixed with cattle that are free of restriction. To do so may lead to restriction of the entire group.

CONSIGNOR (SELLER) NOTES FOR GUIDANCE

Important - The consignor (seller) must only use the MC2 forms that have been allocated to him/her - and <u>not</u> those of the consignee (buyer).

The consignor (seller) completes the top form, i.e. the MC2A (white copy). The information entered will be self-copied onto the next three forms. Insert the cardboard flap cover between the MC2D (blue form) and the next MC2A to prevent copying onto the next set of forms.

Part 1 - Details of Cattle

• Identification number - enter the full number for each animal moved as it appears on the animal's ear tag, including the two letter and single digit or three digit country code, herd number, individual's number and check digit if present.

- · Colour e.g. BW for 'black and white'.
- Breed e.g. SIM for 'Simmental' Refer to the first page of your herd register for other codes.
- · Sex e.g. M for 'male', F for 'female', B for 'bull'.
- Date of birth e.g. 01/01/2020 for 1st January 2020.
- BVD Result N.B. 'Animals born on or after 1/3/2016 cannot be moved off farm, except to an NI abattoir, unless they have a negative Bovine Viral Diarrhoea (BVD) result.' It is the responsibility of the seller to provide evidence to the buyer of a negative BVD Result.

Part 2 - Movement Details

- (i) From Premises of Herd Number insert the consignor's (seller's) own herd number, name and address.
- (ii) To Premises of insert the consignee's (buyer's) name, address and herd number (if known). The herd referred to could be a market or abattoir.
- (iii) Insert the date that the animals actually moved off the premises.

Part 3 - Transportation Details

If either the (Seller) or (Buyer) transports the animal(s), tick the relevant box in part 3 (a).

If a haulier is used:

3 (a) Tick the relevant box to indicate who is transporting the animals.

3 (b) Insert the date the animals actually moved off the premises.

3 (c) & (d) The transporter should complete these parts if a haulier is to transport the animals.

3 (e), (f) and (g) These sections only needs to be completed if the journey is more than 65Km (40 miles).

At (e) enter the name of the owner of the animals if this is different from the seller. At (f) enter the time of departure.

At (g) enter the expected duration of the journey, from the time the first animal is loaded until the last animal is unloaded at the place of destination including any planned rest times or stops for any other purpose en route."

Part 4 - Notification Details

- 1. Insert the total number of animals that are listed in part 1.
- 2. Note that your are also signing a declaration that all of the above animals which were born on or after 1/3/2016 had a negative result at their most recent Bovine Viral Diarrhoea (BVD) test and none of the above animals have a BVD DAMPI status.
- 3. When you are satisfied that the form is correctly completed sign and date it.

Part 5 - Lost or Stolen cattle - For Lost or Stolen cattle Parts 1,2 and 5 should be completed as above

The keeper of a holding from which cattle are lost or stolen should forward an MC2 movement document to DAERA within 7 days of the event being noticed to report the details of what has occurred. Relevant information may be entered on the bottom right corner of the MC2 and should, if applicable, include the PSNI number and any further details. Additional sheets may be attached to provide more evidence.

As there will be no "buyer's" details recorded on the MC2 the keeper should record Lost/Stolen in that section.

The Keeper must confirm the reappearance of cattle previously lost to his local DAERA office by completing an MC2 confirming each animal's identity, the date found and a brief explanation of how it was recovered. This MC2 must be signed and dated by the keeper. The animal(s) that have been found will be inspected by a member of the local AHWI staff and if the animal(s) are correctly identified the movement of the ear tag numbers back into the keeper's herd will take place.

As there will be no "sellers" details recorded on the MC2 the keeper should record Lost/Stolen in that section.

Part 1 - Details of Cattle

Check all tag numbers and animal details are correct, place a tick ' \checkmark ' in the Receipt Confirmed column for each animal to confirm that you have received it.

If any of the tag numbers or cattle details on the form do not match the cattle moved, place an '*****' in the Receipt Confirmed column against each animal that does not fit the exact description. Differences in Tag/ID number, colour, sex, breed should be noted in this way.

Part 2 - Movement Details

The consignor (seller) will have completed part 2 (i) and some or all of part 2 (ii). Enter relevant details that may have been omitted from part 2 (ii).

(iv) Enter date of movement off if different from the date at (iii).

Part 4 - Notification Details

Once you are satisfied that all parts of the form have been correctly completed, apply a confirmation sticker (MC2S) marked 'ORIGINAL' to the Consignee's (Buyer's) form (MC2B, yellow) and the matching sticker marked 'COPY' to the Consignee's (Buyer's) copy (MC2C, pink). Sign and date the confirmation of receipt section of the Consignee's (Buyer's) form (MC2B, yellow) once you are satisfied that it has been completed correctly.

Post the Consignee's (Buyer's) form (MC2B, yellow) to your local DAERA Direct Office or hand the form to staff at any DAERA Direct Office.

Keep the Consignee's (Buyer's) copy (MC2C, pink) for your records.

Animal Unaccompanied by Documentation

If an animal arrives on your farm, but is not accompanied by movement notification documents (MC2B & MC2C) you must notify DAERA as follows:

Using the book of MC2 forms issued to your herd, complete part 1 of the Consignor's (Seller's) form MC2A, entering as many of the identification and description details as possible (i.e. identification number, colour, breed, sex).

Complete part 2 (i) of the MC2A if any of the details of the previous herd (or market) are known. Otherwise, leave this section blank.

Complete part 2 (ii) of the MC2A by entering your own herd number, name and address.

Complete part 2 (iii) of the MC2A by entering the date on which the animal was moved off the consignor's (seller's) premises (if known). If unknown, complete Part 2 (iv) of form MC2B by entering the date on which the animal arrived on your premises.

Apply a confirmation sticker (MC2S) marked 'ORIGINAL' to the Consignee's (Buyer's) form (MC2B, yellow) and the matching sticker marked 'COPY' to the Consignee's (Buyer's) copy (MC2C, pink).

Sign and date the MC2B once you are satisfied that it has been completed correctly.

Post the Consignor's (Seller's) form (MC2A, white) and the Consignee's (Buyer's) form (MC2B, yellow) to your local DAERA Direct Office or hand the form to DAERA staff at any DAERA Direct Office.

Keep the Consignee's (Buyer's) copy (MC2C, pink) and the Consignor's (Seller's) copy (MC2D, blue) for your records.




