## **AVP Portal- DECOL- Cancelling an EHC Application**

- In some cases, the portal user may need to cancel an application. The most common scenario in which cancellation may be required is when the exporter or vet become aware of an error in a certificate that has already been issued and is in the public domain. In such instances, the original hard copy certificate must be retrieved by the vet before the application is cancelled to allow the issue of a replacement.
- When the original hard copy certificate has been retrieved, the vet must endorse it with the word 'Cancelled', take a scanned image;







- To complete the cancellation procedure in the AVP Portal, the portal user must then navigate to the **Submission Details** tab of the application to be cancelled.
- The portal user must select the dialogue box where they must record the reasons for cancellation before clicking 'submit'.



- The portal user will be returned to the *Submission Details* screen where they will note the following
  - -Status has changed to 'AVP Cancelled'
  - -Cancellation/Certifying officer identity and comments have been recorded
  - -Date of Cancellation is recorded
