BACKGROUND		

1. Further to SUB 2291 submitted on the 9<sup>th</sup> September 2022, I can now advise:

• On 16<sup>th</sup> September 2022, two of the co-accused, Gerry Farmer and City Industrial Waste Ltd, entered pleas on three charges each in relation to the disposal, treatment



and deposit of waste contrary to Article 4 of the Waste and Contaminated Land (Northern Ireland) Order 1997 on his lands at Mobuoy Road, Londonderry.		
<ul> <li>All charges levelled against co-defendant Gerry O'Malley, have been left on the books.</li> </ul>		
<ul> <li>As noted in SUB 2291, co-defendant Mr Doherty pleaded guilty to all charges on 9<sup>th</sup> September and charges relating to his company, Campsie Sand and Gravel, were left on the books.</li> </ul>		
<ul> <li>Subject to any appeal, this concludes the criminal prosecution of all five defendants</li> </ul>		
associated with this case.		
<ol> <li>Sentencing has not yet taken place. A further hearing has been scheduled for Thursday 22<sup>nd</sup> September 2022 at Belfast Crown Court before His Honour Judge Rafferty KC to commence Proceeds of Crime proceedings and set a date for sentencing.</li> </ol>		
<ol> <li>No Press Release has been issued due to the potential impact such a release might have on the legal proceedings, perceived or otherwise.</li> </ol>
