Thank you for your request for information received by the Department on 22 June 2023 which you sought the information in bold below.

# 1. The total number, names and public contact information of licensed riding establishments that were licensed and operating within Northern Ireland in 2022

# 2. The total number, names and public contact information of licensed riding establishments that were licensed and operating within Northern Ireland in 2020 and 2021

I can confirm the Department holds some of this information.

A list of riding establishments licensed by the Department for at least one day in 2020, 2021 and 2022, is held at **Annex B**. The total number for each year is included.

Some of the information that we do hold, is considered to be third party personal data, of which you are not the data subject. This element has therefore been withheld under Section 40(2) of the Freedom of Information Act. In these instances, the Department is required to consider if disclosure would breach the first Data Protection Principle which states that processing must be lawful, fair and transparent. I have carried out a Lawful, Fairness and Transparency test, which is attached at **Annex A**.

I can confirm the Department does not hold the following information:

- □ **Legitimate interests:** the processing is necessary for the Department's legitimate interests or the legitimate interests of a third party that overrides the data subject(s) rights and freedoms, particularly their right to privacy.

#### **Consideration of Legitimate Interests**

#### 1. PURPOSE

As the disclosure of personal data under FOI is to the world at large doing so on the strength of a requester's private interests alone could constitute a disproportionate and unwarranted level of interference with the data subject(s) rights and freedoms, particularly their right to privacy and family life under the Human Rights Act 1998.

#### 2. NECESSITY

The right of access under FOI does not in itself constitute a **pressing social need**. The Department has considered and not identified any such need for the data subject's right to privacy to be interfered with.

#### CONCLUSION

Having considered all of the information contained within this test, the Department has established that, on balance, there is no lawful basis for the disclosure of third party personal data falling within the scope of the request of which the requester is not the data subject.
