# **DECOL System New Functionality- In-system nomination of an Authorised Veterinary Practice**

- For the attention of exporters who use <u>DECOL</u> to apply for certification of Export Health Certificates (EHCs) or <u>SHA Online</u> to apply for Support Health Attestations (SHAs).
- For certification of live animals, hatching eggs, table eggs, germinal products, animal by-products, hides, skins, pets and zoo animals you must contact an **Authorised Veterinary Practice (AVP)** and ensure that they are authorised for your proposed export. You will find a list of AVPs here:

#### Northern Ireland aPVP Veterinary Practices

- Not all AVPs are authorised to certify all commodities. You must check with the practice/ vet if certification can be provided for your specific commodity.
- Once the AVP has agreed to certify your export, you must make your application in DECOL. <u>This system user guide</u> explains how to make your application, including how to inform DAERA if your export is to be certified by an AVP.
