Memorandum of Understanding

Aim

Build a stronger, more effective working arrangement between the Northern Ireland Environment Agency (NIEA) and the Ulster Farmers' Union (UFU) to deliver improved environmental outcomes in ways that reduce conflict and support improved farm sustainability.

Key Objectives

- Establish a more productive working relationship between the Agency and the agricultural sector by providing a more customer-focused approach to regulation thereby increasing the agricultural sector's understanding of their environmental obligations and level of compliance.
- 2. Help the farming community unlock the commercial advantages that excellent environmental performance can generate in competitive global agricultural markets.
- 3. Improve environmental outcomes through a more effective partnership approach.

Key Outcomes

- A more sustainable agricultural sector in Northern Ireland which delivers improved environmental, economic and social outcomes.
- Development of a positive, interactive, cooperative relationship between the NIEA and the farming community.
- Higher levels of environmental compliance throughout the agricultural sector, resulting in a healthier environment and less need for enforcement activity.
- Continual improvements in the environment through increased numbers of waterbodies achieving "good status", improved conservation status of priority habitats & species and improved biodiversity in the wider countryside.
- Increased farm sustainability through innovative resource efficient practices.
- Increased awareness that good environmental practice can unlock commercial advantages to help meet the growing demands of competitive global agricultural markets.
- Interdisciplinary partnership approach and enhanced stakeholder engagement in decision-making processes and sustainable land use management.

Parties in the Memorandum of Understanding (MoU)



Ulster Farmers' Union

Founded in 1918, the UFU is the largest democratic voluntary organisation representing farmers and growers in Northern Ireland. With over 11,500 farming family members, the UFU is a significant player in the agri-food industry in Northern Ireland.

The agri-food sector is a major player in the Northern Ireland economy and is contributing substantially to every area of NI. The total number of persons working on farms in 2012 in NI was almost 47,000¹ and there are 27,000 people whose main employment is in the food processing sector².

Northern Ireland has a land area of 13,542 km². Lowland landscapes amount to 37% and upland landscapes 33%³. 80% of the land area in Northern Ireland is used for agriculture or forestry therefore the agricultural sector has a significant impact on the local environment and the NI rural landscape reflects hundreds of years of local farming activity. The UFU is committed to working with the Department of Agriculture, Environment and Rural Affairs (DAERA) and the NIEA to deliver a better environment while supporting growth within the agricultural sector.



Northern Ireland Environment Agency

NIEA is an Agency within DAERA, responsible for monitoring and protecting Northern Ireland's environment. NIEA works with its DAERA colleagues to raise awareness of environmental obligations and support farmers in delivering better environmental and economic outcomes, through increased compliance and sustainable farming practices.

The Strategic Objective of NIEA is to create prosperity and well being through effective environment and natural heritage management and regulation.

The Operating Principles are to:

- 1. Make it easy for people to do good business and difficult for people to do bad business.
- Help create a resource efficient Northern Ireland.
- 3. Help people see our environment and heritage as an opportunity, not a barrier.
- 4. Be a customer-focused and people-centred organisation.

Background to the MoU

NIEA has a close working relationship with farmers throughout Northern Ireland on a range of environmental issues. NIEA investigates pollution incidents or other environmental issues, carries out routine monitoring of habitats and works with farmers to protect special sites and features. NIEA is also responsible for the regulation of the more intensive sectors through the Integrated Pollution Prevention and Control legislation.

As sustainable agriculture is dependent upon a healthy environment, there needs to be an effective collaboration and engagement between NIEA and the farming community. This MoU between the NIEA and the UFU aims to improve the working relationship between the parties to support sustainable farming and compliance with environmental legislation.

Party stakeholders

For the purpose of this MoU, stakeholders include UFU employees and members, agricultural fora, eNGOs, community groups and representation from across DAERA as required.

Management of the MoU

The following framework for decision making and management of the agreement has been approved by the two signature parties. A joint MoU Working Group will be responsible for:

- Endorsing and directing implementation action;
- · Reviewing implementation progress;
- Ensuring appropriate resourcing to support implementation of key commitments;
- Interacting with their respective organisations and party stakeholders; and
- Reporting and making recommendations on the progress of the agreement to both parties.

This MoU and progress reports will be made available to the public on the DAERA and UFU websites. Both parties are accountable and responsible for the commitments made in this MoU. This MoU is not legally binding and either party reserves the right to withdraw at any stage if they wish.

Review and reporting

The parties have agreed that this MoU will be formally reviewed after one year from the date of the agreement to assess its effectiveness. This review will also identify areas of focus for the following year and possible amendments to the MoU. The Working Group will meet on a quarterly basis for the first year to review progress on implementing commitments.
