The Environmental Farming Scheme (EFS) claim will be available to Agreement Holders from 8th April 2019.

# Environmental Farming Scheme Section

It is important to note that all EFS agreement holders are required to complete the Land Details Section of the Single Application regardless of whether or not they wish to claim for the Basic Payment Scheme.

If you hold an EFS agreement you will see a claim table similar to the land details table in the BPS claim. If you hold one EFS Higher or Wider agreement the relevant tab will be displayed. If you hold more than one agreement for both EFS Higher and Wider schemes, two or more tabs will be displayed. Click on each tab to display your agreement details and to make a claim for the Option(s) and associated additional Non-productive investments (NPIs) or capital items options.

If you have made a change to your field(s) (split or merged) using the map or field data table when completing your BPS claim then the original field(s) will be coloured grey below. The new field(s) are detailed below the original field. You are required to update the columns - "Amount Claimed", "Completed at time of claim" if appropriate, against the new field(s) for the Option.

### Land with EFS Options that is eligible for BPS payment

In some cases land with EFS Options will remain eligible for BPS for the duration of the EFS agreement and for a further retention period if SFP was claimed and paid on the land in 2008. The codes to be used are detailed below:

#### Explanation of descriptions used on EFS claim tabs.

**Management Unit (Higher agreements only)** – this is the management unit associated with each option or item detailed in your agreement.

**Field Number** – each Field ID is made up from the Farm Survey Number and Field Number.

**Field Area** - the total area shown here will be the total area in ha as identified in your agreement.

**MEA (ha)** – the MEA is our assessment of the maximum eligible area that you can use to claim in each field (but see page 9 of this guide for claiming areas within Higher agreements). The MEA is based on the boundary features less ineligible features that we have shown on your map. Ensure that you check the MEA is accurate before claiming.

**Option/Item Name** – the options and items within your EFS agreement will be listed for you.

**EFS Code** - this is the code associated with each option or item as detailed in your agreement.

**Permanent or Rotational** – states if this option is permanent or rotational to another eligible field(s) that you have management control of.

**Unit Type** – this will tell you how this option is measured: length metres (m), a monetary value  $(\pounds)$ , a numeric value (qty)

**Amount Agreed (Year 1/Year 2)** - this is the amount of this Option(s) on your EFS agreement.

**Amount Claimed (Year 1/Year 2)** - record in this column the amount you wish to claim. You cannot claim for an amount greater than is in your agreement.

**Completed at time of Claim** - tick the box if you have the additional capital item / Non-Productive Investment (NPI) completed at time of claim.

Amount Claimed/ Maintained Year 2 (Year 2 Wider agreements only, commencement date 2017) – for Capital Items Options or Non-productive investments (NPIs), claimed and paid in year 1 of your agreement. This pre-populated figure should indicate the same amount as claimed in year 1 of your agreement. You must continue to maintain and claim for these options/NPIs in each year of your agreement.

Year 1 Amount Maintained (Year 2 Higher agreements only, commencement date 01 January 2018) – for Capital Items Options or Non-productive investments (NPIs), claimed and paid in year 1 of your agreement. Tick this box to indicate that you have maintained the items for Year 2 of the agreement. You must continue to maintain and claim for these options/NPIs in each year of your agreement.

The areas and amounts of EFS Wider options and capital items included in your EFS Wider agreement are prepopulated in the claim section of the Single Application Online.

If you have already completed the work for the item, carefully measure the amount you have completed and if necessary, reduce the prepopulated amount online; e.g. 200 metres of stockproof fencing (SPF) protecting a woodland planting option (ENW) has been included in the EFS Wider agreement. The fence has been completed and measured at 180 metres. The prepopulated claim of 200 metres must be reduced to 180 metres.

Claims for NPIs (capital items) are only eligible for payment where the EFS Wider Options within the field have also been completed and claimed – e.g. a claim for stockproof fencing (SPF) is not eligible for payment unless the EFS Wider Option (such as Tree enhanced boundaries, TEB) has also been claimed.

Check your claim areas against the current LPIS MEA for the field to ensure that you make your claim using the most recent LPIS data available.

If you have made a reduction to your claim for BPS in a field i.e. you have claimed below the MEA due to the presence of an ineligible feature, check if this reduced figure needs to be duplicated in your EFS claim for that field.

- Check your claim areas against the current **LPIS MEA** for the field to ensure that you make your claim using the most recent LPIS data available.
- Your agreement includes one or more **Remedial Management Options** (**RMOs**) for each field. Check that the total area claimed for these RMOs within the field is not more than the LPIS MEA of the field. **NB There are some circumstances in which you may claim an area higher than the LPIS MEA**

**for the field;** for example when claiming woodland (RMO) areas or Non-productive Investments (NPIs) such as rush control etc. See table below.

- If you have made a reduction in your claim for BPS in a field i.e. claimed below the MEA due to the presence of an ineligible feature, check if this reduced figure needs to be duplicated in your EFS claim for that field (except for NPIs used to control that ineligible feature, See table below.
- Ensure that you have claimed the minimum amount required per field or agreement for each RMO and/or NPI.
- The areas and amounts of **NPI** items included in your EFS Higher agreement are prepopulated in the claim section of the Single Application Online.
- If you have already completed the work for the item, carefully measure the amount you have completed and if necessary, reduce the prepopulated amount online; e.g. 200 metres of stockproof fencing (SPF) protecting a breeding wader RMO (BWG) has been included in the EFS Higher agreement. The fence has been completed and measured at 180 metres. The prepopulated claim of 200 metres must be reduced to 180 metres.

#### **Claiming for Woodland Remedial Management Options**

- Ensure that you claim for areas of woodland that you are managing and have been included in your EFS agreement under normal circumstances you should not make a zero EFS claim for woodland options.
- Claims for fields which include woodland RMO's (grazed or ungrazed, see Table below) may exceed the MEA of the field. This is because managed woodland areas which are ineligible for BPS are eligible for EFS payments. Your EFS area claim for a particular field will be higher than the LPIS MEA and your BPS claim in that field if the field contains EFS woodland.

#### Claiming for scrub, bracken and rush control

- Claims for scrub, bracken or rush control options (See Table below) may exceed the LPIS MEA of the field. This is because areas of scrub, bracken or rush which are currently ineligible for BPS but which have been included as a scrub/bracken/rush control NPI within your EFS agreement are eligible for these EFS NPI payments.
- Claims must accurately reflect the area where control of scrub/bracken/rush has been completed. This area may be less than the area of scrub/bracken/rush control included in your EFS (H) agreement. Overdeclaration penalties will be applied where post-claim checks determine that the area claimed exceeds the area completed.

#### Claiming for treatment of invasive non-native species

- Claims for treatment of invasive non-native species (such as rhododendron or laurel, see Table below)) may result in a claim exceeding the LPIS MEA of the field. This is because areas of invasive non-native species which are currently ineligible for BPS but which have been included as a control of invasive species NPI within your agreement are eligible for these EFS NPI payments.
- Claims must accurately reflect the area where control of invasive non-native species has been completed. This area may be less than the area of invasive non-native species control included in your EFS (H) agreement. Over-declaration penalties will be applied where post-claim checks determine that the area claimed exceeds the area completed.

#### Claiming for Non-Productive Investments NPIs (Capital Items)

 Claims for NPIs are only eligible for payment where you have also completed and claimed for management options within the field – e.g. a claim for stockproof fencing (SPF) is not eligible for payment unless the RMO (such as breeding wader remedial management) or a vegetation control NPI (such as rush control) has also been completed and claimed.

- If a field in your agreement is managed under 'No Higher Option' (NHO) you
  must claim for the NHO area to ensure that any Wider Options and associated
  NPIs approved and completed in that field remain eligible for payment.
- Claims must accurately reflect the area/length/units of NPI completed. This may be less than the area/length/units included in your EFS (H) agreement. Over-declaration penalties will be applied where post-claim checks determine that the amount claimed exceeds the area/length/units completed.

**Unit Type - LU** = Livestock Units. An Irish Moiled cow is equivalent to 0.8 LU. Female animals aged 12 - 24 months are equivalent to 0.6 LU and those aged 6 - 12 months are equivalent to 0.4 LU.

Please note that female animals are only eligible if registered on the Irish Moiled Cattle Society Breed Register. The claimed number of female Irish Moiled animals must have been or remain in the herd for the claim year period.

Amount Agreed (Year1/Year2) - this is number of LU on your EFS agreement.

**Amount Claimed (Year1/Year2) –** this is the LU on 01 January 2019 for the period 01 January 2019 – 31 December 2019. You cannot claim for more Livestock Units (LU) than the number in your agreement.

**IMCS Membership Number –** this is your Irish Moiled Cattle Society Membership number.

**Manage Ear Tags** - Ear tag numbers for claimed female Irish Moiled animals must be provided so that a cross reference with APHIS and the Irish Moiled Cattle Society Breed Register can be made. Click on "Manage Ear Tag" button and the following box will appear.

**Ear tag format** – UK registered animals require 14 digits. Only the first two are alphabetical, the remaining 12 are numerical. ROI registered animals require either 14 digits or 15 digits, depending on the date of registration.

### IMPORTANT

- Your EFS agreement is based on the maximum number of Irish Moiled Cattle (IMC) livestock units (LUs) that you intend to retain over the five years of the agreement.
- You should claim for the number of Livestock Units of IMC which you hold on 01 January 2019 and which you intend to retain in 2019. Do not claim for the number of animals which you hold. Check your online application carefully to ensure you have claimed the correct number of Livestock Units.
- Claims may be made for any amount **equal to or less than the number of eligible Livestock Units** included in your EFS agreement.
- You **must** individually identify the animals you are claiming for by supplying their DAERA Ear Tag numbers.
- Eligible animals must:
  - o Be female
  - Be at least 6 months of age at the start of the claim year (01 January 2019).

- Remain in the herd for the claim period 01 January 2019 to 31 December 2019
- Have ear tag numbers that cross reference with APHIS/NIFAIS
- Be registered with the Irish Moiled Cattle Society.
